In accordance with the requirements of the Interstate Commerce Act and the Rules and Regulations of the Federal Energy Regulatory Commission ("F.E.R.C."), SP 49 Pipeline LLC ("SP 49") submits for filing the following tariffs, effective July 1, 2024:

The rates in F.E.R.C. Nos. 3.18.0, 4.17.0 and 5.17.0 are modified in accordance with the tariff rate indexing provisions of 18 C.F.R. § 342.3. The new rates in F.E.R.C. Nos. 3.18.0, 4.17.0 and 5.17.0 are in all cases less than or equal to the corresponding new ceiling rates. The new ceiling rates have been calculated in the attached Schedule A in accordance with the Notice of Annual Change in the Producer Price Index for Finished Goods issued by F.E.R.C. on May 15, 2024, in Docket No. RM93-11-000.

In addition, the name and contact of the issuer has been updated on each tariff.
